महोदय / महोदया,

With reference to the subject mentioned above, please find enclosed a copy of KVS Hqrs letter no.F.11-EDPOLA/1/2022-Academic dated 23.02.2022 wherein it was informed that fresh admissions to class I is going to start from 28<sup>th</sup> February, 2022 through Online Admission Portal. The registration will remain open till 21.03.2022. For Class II onwards, the admission process will commence (if vacancy exists) as per Admisison Schedule 2022-23.

Accordingly following relavant documents are being sent for information and smooth execution of Admission process.

1. Admission Guidelines 2022-23 : Admisison Guidelines duly approved by the Competent Authority are enclosed.
2. Admisison Schedule 2022-23 : The Admission Schedule for Fresh Admissions for Academic Session 2022-23 duly approved by Competent Authority is enclosed.
3. Admisison to Newly opened KVs : All newly opened KVs open till February 2022 will conduct Class I admissions in Online mode through OLA Portal and for other classes in Offline mode only. The schedule for admission to class II onwards (offline) as mentioned in Admission Schedule 2022-23 will not be binding for them as full strength 40 is to be admitted. The Principals of newly opened KVs to follow Online mode of registration of applications through Vidyalaya Website and Email ID to avoid the large gathering of applicants / parents in Vidyalaya. The Registration form for Class II onwards is already uploaded on Website of each KV under Common Document tab of website with instruction to parents to download the fill the registration form, scan the filled Registration form and send it to Vidyalaya email id.

4. Admission to Class II onwards : The vacancies, if any, from Class II onwards is to be uploaded on the Kendriya Vidyalaya's website by the Principal for the information of stakeholders. Sample Registration form from class II onwards is available under Common Documents tab of website.
5. The directions of MHA/State Govt/District Administration/ Local authorities to contain the spread of Covid-19 are to be followed scrupulously for safety of employees / visitors.

Moreover, modalities for Online Admissions & other details will be sent separately on receipt of the same from KVS Hqrs.

Hence, all the Principals are hereby instructed to ensure compliance of directions / guidelines given by KVS Hqrs.

**NOTE THE FOLLOWING CHANGES:**

1. A Child must be 6 years old as on 31st March in the academic year in which admission is sought for Class I. (Child born on 1st April should also be considered).
2. Children orphaned due to Covid-19 will be considered for admission over and above the class strength under PM CARES for Children Scheme. The admission will be done on the basis of list given by District Magistrate of the concerned District subject to 10 children per KV and maximum 02 children per class. These children will be exempted from payment of fees (Tuition fee, Computer fund, and VVN) from Classes I to XII.
3. **METHOD OF ADMISSIONS IN CLASS XI KV Students:** Admission in different streams, Science, Commerce & Humanities be based on merit upto maximum 55 strength in case of KV students as per availability of streams in the Kendriya Vidyalaya. Choice of stream will be taken from students with parent consent before declaration of merit list. Stream will be allotted on the basis of marks obtained in Class X CBSE Board Examination. Once the seats exhausted in one stream students have to take admission in the other available stream in that Vidyalaya. Undertaking is to be obtained from students before finalization of merit list by KV.
